Introduction:

The Drug Free Schools and Campuses Regulations (34 CFR Part 86) of the Drug-Free Schools and Communities Act (DFSCA) require an institution of higher education (IHE) such as Lubbock Christian University (LCU) to certify it has implemented programs to prevent the abuse of alcohol and use or distribution of illicit drugs both by LCU students and employees on its premises and as a part of any of its activities. At a minimum each institution of higher education must annually distribute the following in writing to all students and employees:

- Standards of conduct that clearly prohibit the unlawful possession, use or distribution of illicit drugs and alcohol by students and employees;
- A description of the legal sanctions under local, state, or federal law for the unlawful possession or distribution of illicit drugs and alcohol;
- A description of any drug or alcohol counseling, treatment, or rehabilitations or reentry programs that are available to employees or students; and
- A clear statement that the institution will impose sanctions on students and employees and a description of those sanctions, up to and including the expulsion or termination of employment and referral for prosecution, for violations of the standards of conduct.

The law further requires that an institution conduct a biennial review of its program with the following objectives:

- Determining the effectiveness of the policy and implementing changes to the alcohol and other drug programs if they are needed; and
- To ensure that the sanctions developed are enforced consistently.

C. On – Going Resources & Programming

The LCU Counseling Center offers individual counseling, education, and intervention to students who abuse drugs, alcohol or any other substance. Clients provided services may be referred to community services as deemed appropriate.

On-Campus Resources

- BASICS (Brief Alcohol Screening and Intervention of College Students) - a Harm Reduction Approach, is a preventive intervention for college students 18 to 24 years old. It targets students who drink alcohol heavily and have

experienced or are at risk for alcohol-related problems such as poor class attendance, missed assignments, accidents, sexual assault, and violence. BASICS is designed to help students make better alcohol-use decisions based on a clear understanding of the genuine risks associated with problem drinking, enhanced motivation to change, and the development of skills to moderate drinking. The program is conducted over the course of three brief interviews that prompt students to change their drinking patterns. The program's style is empathetic, non-confrontational or non-judgmental, and aims to (1) reduce alcohol consumption and its adverse consequences, (2) promote healthier choices among young adults, and (3) provide important information and coping skills for risk reduction.

- **Counseling Center** - provides assessment, intervention, education, and referral sources for all members of the LCU community who experience problems or have concerns about their use of alcohol or other drugs. Anyone seeking counseling services is entitled to an intake or consultation counseling session free of charge. After the initial session, each subsequent session is \$10 each. Clients may be self-referred or be mandated through a variety of university departments. All services are provided by graduate students, licensed, or license-eligible counselors.
- **Self-Evaluation** - an interactive web survey that allows college and university students to enter information about their drinking/drug use patterns and receive feedback about their use of alcohol/drugs. The assessment takes about 6-7 minutes to complete, is self-guided, and requires no face-to-face contact time with a counselor or administrator. The feedback provided is intended to help individuals assess alcohol consumption patterns or drug usage and determine the level of harm or level of risk for future harm regarding substance abuse.

- Student are required to enrolled in and complete IDAP. (Intelligent Decisions Advocacy Program)

Sanction #2

- IDAP Sanctions/Personal Beliefs Paper
- Sanction Detail
- Student are required to write a five-page, 12 pt. font, double spaced paper, with three sources. This paper will cover the topic of How My Personal Beliefs Influence the Decisions I Make. In this paper students will integrate the three sources (internet research, books, journal articles, etc.) and their personal insights to develop a plan to show how decision making, both poor and positive, correlates with his own personal values, and how it can have a lasting impact on your success as a student. Any plagiarism on this paper will result in immediate dismissal from Lubbock Christian University.

Sanction #3

- Probation Sanctions/Substance Counseling
- Sanction Detail
- Student required to attend Alcohol and Drug awareness counseling in the University Counseling Center (contact: Counseling@lcu.edu) for as many sessions as deemed necessary by the counseling program director. Missed appointments will result in additional university sanctions.

- According to the Federal Rights and Privacy Act (Federal Law), if the student is a minor, a letter will be sent to the parent(s) or guardian explaining status of their student as a result of violation of the institutional alcohol policy.

Modified Sanctions:

Sanction #1

- Student is required to write a seven-page, 12 pt. font, double spaced paper, with three sources. This paper will cover the topic of alcohol education initiatives on college campuses. Any plagiarism on this paper will result in immediate dismissal from Lubbock Christian University.

The Lubbock Christian University DFSCA Committee has made the following recommendations for the next two academic years:

- A. Counseling Center**
 - Counseling Center will develop better modalities of communication regarding drug/alcohol resources.
- B. Dean's Office**
 - Will provide sanction assessment for review by committee in Dec 2021 or Jan 2022
- C. Title IX Office**
 - Continue drug/alcohol awareness & education pieces in all Title IX functions
- D. Center for Student Success**
 - Will coordinate with the Counseling Center for staff education regarding referrals and resources. Target date- Fall 2021
- E. Student Life**
 - Continue programming for students
 - Explore tracking system for all education/awareness programming
- F. Student Body**
 - Work on ways to utilize social clubs, senate, and other forums for outreach
- G. Faculty**
 - Communication & presentation to faculty
- H. DFSCA Committee**
 - Mid Term meeting for progress review – Dec 2021 or Jan 2022
